This is to certify that I, as parent or legal guardian of (child's name) _____, a player in the TORO SOFTBALL, Inc., hereby grant permission to the adult manager/coach of my child's team, or other league representative to obtain medical care at my expense, from any licensed physician, hospital, or medical clinic, for the player named herein at such times as either parent or legal guardian cannot be contacted in person or by telephone. This authorization shall include all league activities, including the period required to travel to and from those activities; and we hereby waive, release, absolve, indemnify, and agree to hold harmless TORO SOFTBALL, Inc., organization; the organizers, supervisors, officers, participants, and persons transporting the player to and from those activities, for any and all claims arising out of an injury to the player. I understand the league carries minimal secondary medical coverage and my own medical insurance is primary. I understand I am responsible for, at a minimum, the primary medical costs and all primary deductibles in the event of an injury. This authorization will cover the player named above, year over year, or anytime they participate in a TORO SOFTBALL, Inc. sanctioned event, unless revoked in writing by the parent or legal guardian.

I further agree to return all equipment provided by the league, with the exception of items designated by the league in writing, which the player can keep, at the time and place designated by the players Coach. Failure to do so will result in my being responsible for full replacement cost of such item(s). I will also be responsible for any malicious damage caused by my child to TORO SOFTBALL, Inc., equipment, grounds, or facilities. I also understand that should I resign my child from the league after February 28, or my child is removed at any time due to malicious behavior or severe rule violations, that no refunds of registration or other fees will be warranted.

I understand my child cannot participate until a copy of his/her birth certificate is on file with the TORO SOFTBALL, Inc. I also understand that by signing up my child to play for TORO SOFTBALL, Inc., I am agreeing that priority will be given to Toro regular season games and practice schedules over travel baseball teams or other sports activities. If I miss one scheduled game or two practices due to travel softball outside of the Toro league, or another sports activity, I will be asked to forfeit the season with no recourse against the Toro league or it's volunteers as to registration fees or other incurred expenses (to include All-Stars if selected).

I also understand that I am volunteering my time to work in the snack bar at Toro field. If I fail to show up on my scheduled time, or fail to find a suitable replacement to fill my schedule in my absence (18 years of age or older), I will reimburse the league a fee of \$50.00 and it will be added to my following years registration fee.
